

Commitment Letter for Cornerstone Academy 2026-2027

This letter is to inform Cornerstone Academy of my intent to enroll my student/s, _____, at Cornerstone Academy for the 2026-2027 school year. She/he will be going into _____ grade. I understand that before and after school arrangements will need to be made *separately* upon enrollment in Cornerstone Academy; see additional page for information regarding Before and/or After School Care.

If I **DO NOT** need Before and After School Care, I understand that my student/s must be dropped off between 8:15-8:25 am at Cornerstone Academy and be picked up no later than 3:35 pm. Our learning day begins promptly at 8:30am. In accordance with Missouri's Compulsory Attendance Law there is a limit to the number of tardies that will be allowed before disciplinary action is taken.

I understand that if for some reason Cornerstone Academy will not be in school, Cornerstone will contact parents via text and/or email. Please be advised that Cornerstone often has class even when Ray-Pec cancels due to inclement weather. Cornerstone is to be flexible in this way because we do not have to worry about bus routes, etc. and we are thereby able to have school on days where Ray-Pec may not be able.

By signing below, I acknowledge that choosing to enroll at Cornerstone Academy is a commitment to the growth and development of my student/s. Cornerstone's first priority is to provide a top-notch learning experience especially adhering to their maxim: **Learn, Work, Play**. I understand Parental involvement outside of the classroom is encouraged and necessary to further the growth and development of my student/s. I understand Cornerstone Academy's teachers and administrators are available outside of class times to meet and discuss concerns, should they arise. I understand that inappropriate or unprofessional parental behaviors as well as the absence of parental involvement will not be tolerated and will be subject to disciplinary action including but not limited to expulsion of my student/s.

Intent to Enroll in Before and/or after School Care Cornerstone Academy 2026-2027

This letter is to inform Cornerstone Academy of my intent to enroll student/s _____, in Before and/or After School Care at Springing Up and Cornerstone Academy for the 2026-2027 school year. She/he will be going into _____ grade. I understand that before and after care arrangements will need to be made upon enrollment in Cornerstone Academy. Any non-attendance days for the school year are considered before and after care. If Springing Up is open, these students are eligible to attend. This includes long breaks such as Christmas Break or Spring Break.

If you **DO NOT** need Before and After School Care, my student/s must be dropped off between 8:15-8:25 am at Cornerstone Academy and be picked up no later than 3:35 pm. On no-school days your student/s will **not** be eligible to come to SU if arrangements have not been made.

If for some reason Cornerstone Academy will not be in school due to weather, parents will be notified via text and/or email.

Be advised that classes may be in session even if there is inclement weather. We often have class even when Ray-Pec does not due weather. Why? Because we do not have to worry about bus routes, etc. Therefore, we are able to have school.
